

# Biomass Utilization Fund



The **Biomass Utilization Fund (BUF)** was allocated \$17 million in federal funds to help finance new or expanding businesses located or locating in Tuolumne County that are capable of using the available biomass from the surrounding forests and provide an alternative

to pile burning of forest waste. Businesses are required to use or supply forest biomass as a part of their operations and to provide permanent employment opportunities to low- and moderate-income individuals. California Department of Housing and Community Development (HCD) research suggests that there are 44,000 tons of bone-dry wood available annually to support new business opportunities. HCD partnered with SNC to lead the effort to establish a new Biomass Utilization Fund to encourage the use of forest biomass and increase community and forest resilience. HCD and SNC have entered into an agreement with Rural Community Assistance Corporation (RCAC) to manage the Biomass Utilization Fund.

## Application Process

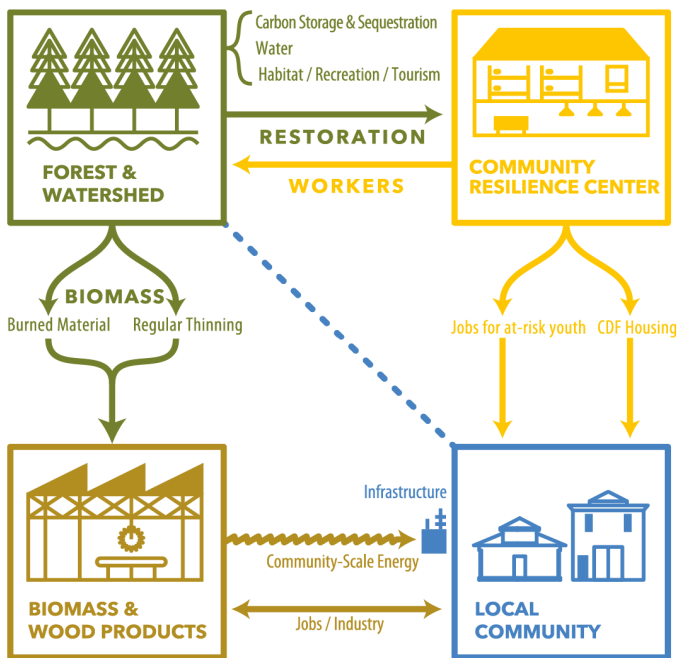
- Applications are being accepted now, and all applications received by **June 12, 2020** will be given the same consideration with the highest ranking, substantially complete applications moving forward first. Applications received after June 12 will be evaluated based on the availability of funds.
- Initial review will focus on project feasibility, estimated use of biomass and job creation potential, followed by economic viability of the proposed business and the need for BUF financing.
- Priority will be given to projects that will utilize the most biomass and create the greatest number of permanent jobs for low- and moderate-income people.

## Eligibility and Program Requirements

- Small businesses, nonprofits, and public entities including federally recognized Tribes located or locating in Tuolumne County are eligible to receive funds under the BUF.
- Funding is limited to businesses located or locating in **Tuolumne County**.
- The fund is prohibited from substituting for conventional financing. Applicants will be required to bring equity and/or other financing to the project, or apply for other available RCAC loan products.
- BUF funds will be made available at 3% interest amortized over 30 years, but applicants may be eligible for additional subsidies if required by the financial analysis to ensure business viability.
- BUF assistance will be provided only to the extent needed to ensure the business is viable and that the business will provide a reasonable rate of return to the owner.
- Projects are required to create new, permanent jobs, predominantly for low- to moderate-income people.
- Recipients of BUF funds must document job creation and expend all funds by **April 30, 2022**.
